VIRGINIA, May 8.—The floating body of an unknown man was found by some boys on the west shore of Virginia lake Thursday noon. There was nothing on the remains to identify the man and there is no one missing from this city. At first it was thought that it might be one of the employes of the Bailey Lumber Co., but they could not identify him.

Dr. C. B. Lemont is this week erecting a hospital at Camp 6 on the new road, he being the company surgeon.
