Injustice to Mr. Hartley.

Friends of John J. Hartley claim that the action filed by E. P. Stacy & Sons, of Minneapolis, in the United States court in which they object to the discharge as bankrupts of Hartley & Chelley, works an uncalled for injustice to Mr. Hartley. The objection states that he absconded from Duluth, going to Buffalo and from there it is not known where he did go. As a matter of fact they say Mr. Hartley left Duluth in order to obtain employment and it can readily be ascertained at any time where he is by anyone interested.
