Marriage licenses were issued yesterday to Frank Kolm and Bessie Slonim, and Anders Mobrotten and Anna Toner.

Second Citizenship papers were issued yesterday in the district court to Andrew Erickson, a former subject of the king of Norway and Sweden; first papers were issued to John Peters, a former subject of the emperor of Austria.

The Spruce Mining company has purchased of Jessie L. Savin, of Stillwater, timber standing on lands in section 13, 14, and 23-60-13, for \$4,200, the transfer having been recorded with the register of deeds yesterday afternoon. Alfred W. Kuehnow and wife have deeded to Martin L. House for a consideration of \$4,700 all of section 19-51-17, containing about 650 acres.

Two more property owners on East Superior street are dissatisfied with the assessment made by the board of public works to pay the cost of paving the thoroughfare from Eighth to Sixteenth avenues east, and have filed appeals in the district court. They are Percival M. Shaw owner of lot 8, block 10, Banning & Ray's subdivision of Endion, and M. H. Stanford, who owns lots 12 and 13, block 79, Endion division, and their objection are the same as those of the property owners filed several days ago.

Judge Cant yesterday morning filed an order in the district court denying the motion of the defendants for a new trial in the case of the Buffalo Land & Exploration company against Hugh P. Strong and others. The action involved some iron ore lands and judgment was rendered in favor of the plaintiff at the January term of court. The defendants argued that the verdict was not justified by the evidence and was contrary to law.

In the case of Robert M. Stitt against the Rat Portage Lumber company a stay of proceedings has been ordered by Judge Ensign. The case involved some timber and the plaintiff secured a verdict at the completion of the trial.

County Attorney McClintock has received a letter from the state board of Pardons asking for information regarding Oscar L. Cook, alias Herbert Richey, who it is claimed in the communication was sentenced from St. Louis county in 1900 to serve a seven-year sentence for forgery. The records disclose no such case.
