Certificate of Incorporation

Know all men by these presents that the undersigned do hereby associate themselves together for the purpose of forming a corporation pursuant to the provisions of Chapter 53 of the Revised Laws of Minnesota for the year 1905, and to that end do hereby sign and adopt the following certificate of incorporation.

ARTICLE I. The name of this corporation shall be PATTERSON BOAT AND LAUNCH COMPANY, and the general nature of its business shall be to engage in water transportation of passengers and freight upon the Great Lakes, their connecting and adjacent waters and upon any waters of the United States or elsewhere, and for such purpose or otherwise to construct, own, buy, sell, mortgage, charter, lease and operate launchers, row-boats, and all species of sailing, steam or other species of vessel property, or water craft of any sort, and to own, buy, sell and operate docks and wharves.

ARTICLE II. The time of the commencement of this corporation shall be the 27th day of May, A. D. 1907, and the period of its continuance shall be thirty years.
