

# MANY LICENSES ARE GRANTED BY CITY COUNCIL

## Application of E. A. Smith to Conduct Drug Store in West End Is Laid Over.

For the second time, the application of E. A. Smith for a drug store license at 1932 West Superior street was laid over by the city commissioners. When Smith's application was submitted to the council again yesterday, Commissioner of Public Utilities F. G. Phillips suggested that it be again held over for further investigation.
