

TWELVE DENIED RIGHT TO VOTE; TEN RECEIVE IT

Judge Page Morris to Hold Another Hearing Tomorrow For 28 Aliens.

Certificates of citizenship were granted to ten applicants out of 22 at the hearing held in United States district court yesterday before Judge Page Morris. The petitions of the remaining 12 were continued because the applicants were insufficiently versed in American civil government. In the cases of three German aliens their applications were held up pending information from Washington as to their status under the enemy alien enactment.

Three of the applicants were former soldiers who saw service in France. A hearing on citizenship applications will be conducted by Federal Examiner R. K. Doe in county district court tomorrow morning. Eighty-two petitions have been filed.

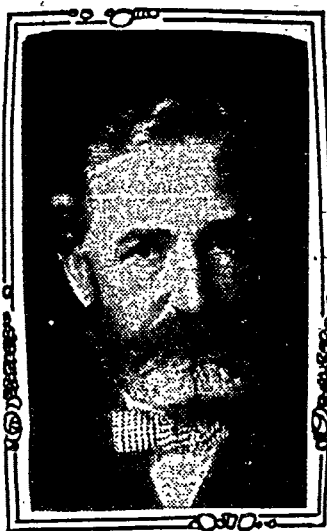
